

CANOE CAMPING & RUSTIC CAMPING INFORMATION GUIDE

ABOUT CANOE CAMPING

Registration : At Rupert's reception, by phone (418-748-7748) or email (reservesaamw@nibiischii.com)
Reception schedule (May to September) 7am to 4pm daily
(Off season) 8:30 am to 4 pm Monday to Thursday

Facilities : Depending on the route, some facilities are in place (Lake Robineau route from August 2021). However, all other routes are not developed. Some portages and rustic campsites are used more frequently, but are not the responsibility of the Nibiischii Corporation.

Services : No services are available for canoe camping and primitive camping

Fishing* : if you intend to fish, it is mandatory to obtain a fishing access right. Access is restricted to certain lakes and the quotas available are limited.

** additional fees are applicable*

ATTENTION FISHERMEN !

Access rights are issued on a 24h basis. They are therefore valid from the time of issue on the day of arrival until the same time on the day of departure.
ou will have to pay the cost of the access rights for the whole group, for the total duration of your stay. **In the event of a late outing, each member of the group will be required to pay the cost of an additional day's fishing.**

CANOE CAMPING PACKAGE – Free circuit

Place : Possibility of obtaining a right of access for canoe-camping on the majority of the lakes of the Assinica Wildlife Reserve and the Albanel-Mistassini-and-Waconichi Lakes. Some lakes are restricted.

Processus : At least one month before the start of your expedition, contact the Nibiischii Corporation to provide:

- whether you wish to fish or not (with locations and dates);
- a brief document outlining your experience and that of each member of your expedition;
- description of the boats;
- satellite and emergency phone numbers;
- and other necessary information (indicated in the Trip Plan document).

Fill out the risk acceptance form.

We will proceed to the analysis of your request and prepare the access rights according to your itinerary.

ROBINEAU PACKAGE WITH ACCOMODATION IN COOLBOX – 7 days

Package :

- Boats not included.
- Right of access for canoe-camping included for the 7 day tour of Lake Robineau.

Catch and release : MAandatory catch and release at Robineau lake and surroundings streams and rivers

The consumption of fish is allowed on site only. All fish, released and consumed, must be declared on the catch register of each group of fishermen. No fish can be brought back.

Products and services :

- 1 large Cool Box (12 x 24 ft - 24 x 30 ft floating platform) equipped with: 4 single, bunk, wooden beds, futon (can accommodate 1 child), contour sheets and pillows with pillowcases, shower, composting toilet, 1 rectangular table with 4 chairs, propane fridge/freezer (6 cu. ft.), 2 round propane cooktop, dishes (8 place settings), dish soap, pots and pans, coffee maker, kettle, toaster, utensils, storage cabinet, broom, dustpan and mop. BBQ and screened terrace outside. Mop for rowboats, oars, PFDs, extra boat plugs, etc.
- INTEGRATED EQUIPMENT AND SYSTEMS: The Cool box is equipped with a propane heating system, propane water heater, propane toilet, solar panels for lighting and power outlets, water tank, grey water recovery pump.
- Tent platforms at kilometers 18 and 54 of the tour (corresponds to nights 2, 4 and 6 of the tour) with pulley system to hang food against the bears.
- Optionnal attraction : block field

RUSTIC CAMPING

- Fishing-camping stays must be for a minimum of 2 nights.
- Camping fees included in the package (day rate/person, minimum 2 pers.)
- Fishing fees not included (daily rates/person).
- Maximum of 6 people per group (including children).

Arrival : 1pm

Departure : 1pm

OTHER INFORMATION

Leave no trace : The principle of Leave No Trace Tourism aims to prevent and minimize the impacts of recreational activities by reducing the damage caused by various activities, as well as by promoting principles of courtesy and hospitality towards other visitors and the environment. This includes exercising good judgment by preparing in advance, choosing good campsites, disposing of garbage properly, and avoiding disturbance to flora and fauna. Quietness and respect: Please respect the quietness and the infrastructures on the site. The buildings on the site belong to the Neeposh family and are not available to visitors. Please respect the premises.

Cleanliness: A cleaning fee of \$100 may be charged to clients who do not leave the premises clean.

Non-drinkable water: The water on site is not potable for drinking. It is recommended to bring drinking water or to boil the water available on site for 10 to 20 minutes.

Territory: The territory managed by the Nibiischii Corporation is immense. It includes more than 5 000 lakes. The season of operation being about 4 months, it is very difficult to ensure a quality access and an update of the information for all the water bodies. In addition, many users circulate and occupy the territory which can, in certain situations, accelerate the deterioration of certain roads. Therefore, it is not possible to guarantee the condition of the roads and the launch and access is at the client's own risk. The right of access is non-refundable.

On the road: A 4 x 4 vehicle with good ground clearance is recommended, or even required for access to certain bodies of water. It is strongly recommended to bring two (2) spare wheels, fully inflated, as the distance to cover on gravel roads is considerable. The use of ATVs is prohibited in the wildlife reserve, with some exceptions.

On water :

- Remember that navigating large, unmarked bodies of water where there are many rocky outcroppings and where weather changes can quickly create dangerous conditions, requires constant attention.
- **Avoid fines !**
 - Carry your provincial fishing liscence at all time
 - Return your catch to the water
 - Wear a personal flotation device (PFD)
 - Have a water safety kit in your boat

Pets: Pets are strictly forbidden in the accommodations.

Smoking in public places: Smoking is strictly prohibited in the accommodations, rental units and all public buildings of the wildlife reserve. To find out about the rules in effect in our wildlife reserve, please contact the establishment.

Other

- Guiding services are not provided
- Take a flashlight with you when you travel at night.

RESOURCE PROTECTION

Catch and release : Catch and release allows for sound management of species and promotes a good quality of fishery for present and future generations. This practice improves or maintains the condition of fish populations and the quality of the fishery.

Reminder for a safe and responsible expedition

- All outdoor activities involve risks that all participants must be aware of. Everyone must ensure that they have the necessary skills and abilities for the activities they are involved in.
- Federal regulations prohibit anyone from operating a motorized vessel **unless they have proof of having successfully completed a boating safety course** in Canada prior to April 1, 1999 or a Pleasure Craft Operator Card issued following the successful completion of a Transport Canada approved test.

As stipulated in the wildlife reserve regulations, any person who engages in fishing activities must, upon leaving the wildlife reserve, report this activity at the location determined for this purpose, indicating his or her daily catch (located on the back of the right of access). Any violation of this regulation constitutes an offence and is subject to a minimum fine of \$250.

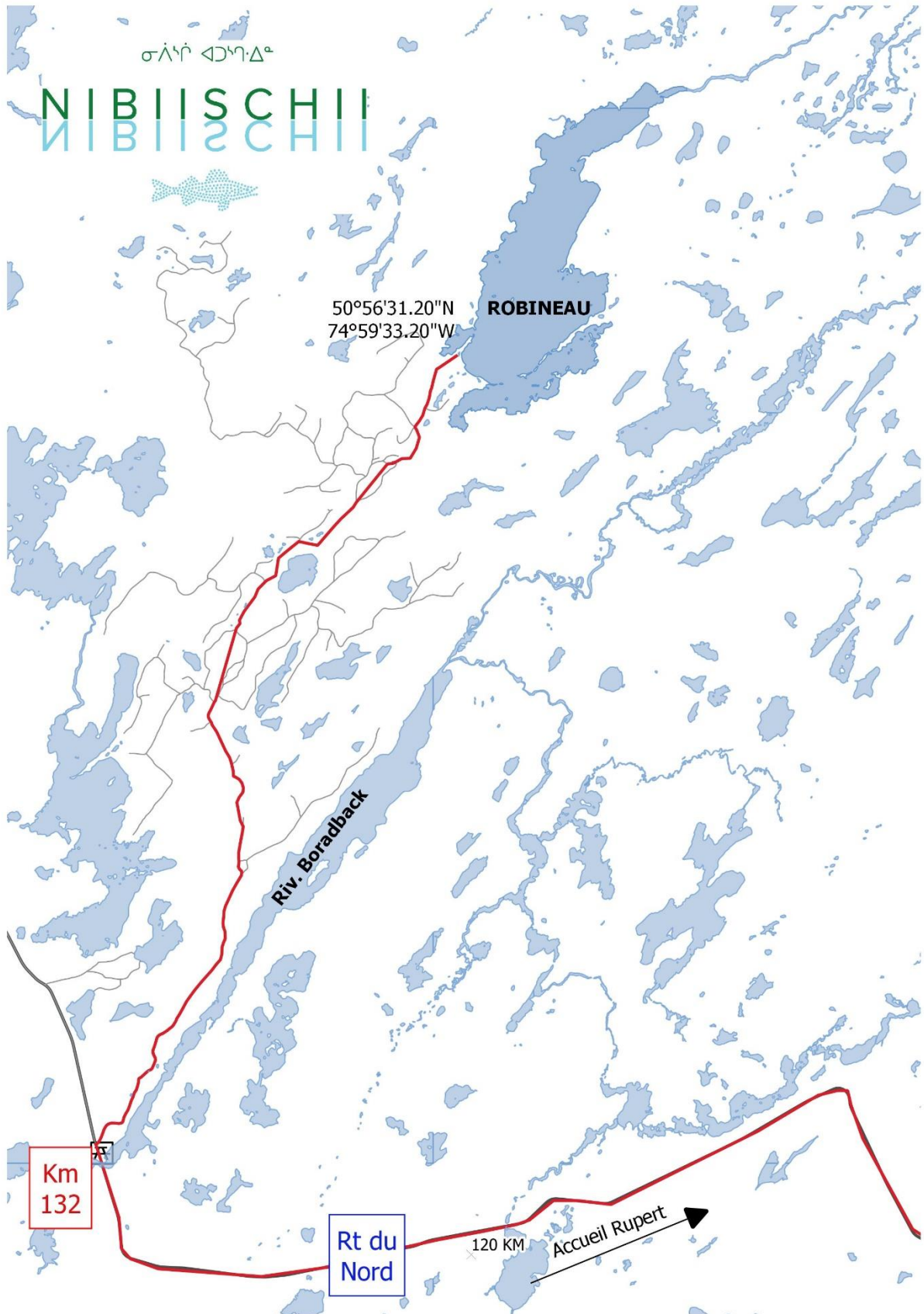
