# LODGINGS



## MÛS PROSPECTOR CAMP J<sup>6</sup>

**2 large Mûs camps** 3.5 x 6 m (12' x 20') insulated for 6 people, equipped with 2 wooden bunk beds (double mattress on bottom and single on top), fitted sheets and pillows with pillowcases, a table with 6 chairs, electric fridge and freezer, crockery (8 place settings) with frying pans, saucepans, coffee maker and toaster, utensils, dishwashing equipment, counter and storage space, wood heating (wood included).

The camps are equipped to run on electricity. A generator is required to use the electrical equipment indoors. There is no running water in the camp, but nearby Robineau Lake provides a source of water.

**Outside the camps:** Mosquito shelter with picnic table, propane stove (propane not included), outdoor fireplace, outdoor table/sink, dry toilet, BBQ.

## CANOE-CAMPING

Lake Robineau Circuit

The Robineau Lake site is a starting and ending point for canoe-camping.

### Visitors can come across Cree fishermen practicing their traditional activities (JBNQA) at the water points.

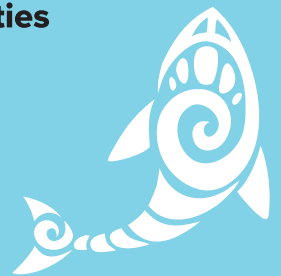
(James Bay and Northern Quebec Agreement (JBNQA)).

We ask you to be courteous and vigilant, nets may still be in use in the spring.

### The camping is next to familial native camps.

It is prohibited to use native camps throughout the territory.

Thanks for keeping the site and water access unobstructed at all times.



## LEAVE-NO-TRACE PRINCIPLE

The goal of the principle of leave-no-trace tourism is to prevent and minimize the impacts of recreational activities by reducing the damage caused by such activities and by promoting principles of courtesy and hospitality towards other users and the environment.

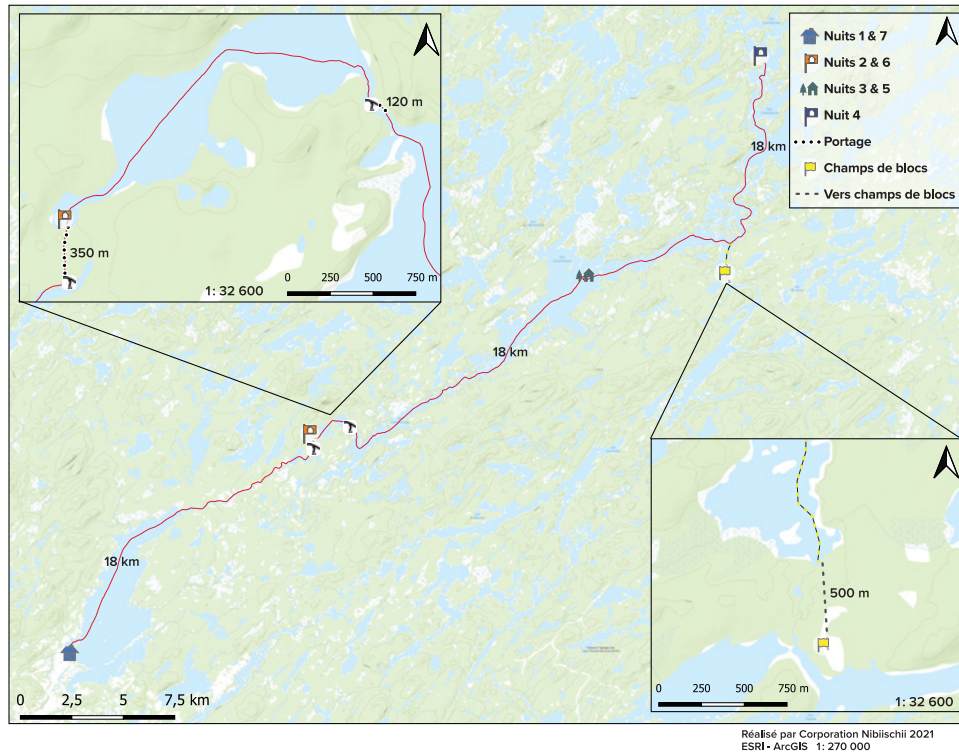
It involves exercising judgment by preparing in advance for the stay, by choosing the right spots for campsites, by getting rid of waste in the proper way and by taking care not to disturb plant and animal life.

## EQUIPMENT TO BRING



- Access right to the territory
- Geolocation beacon
- Personal flotation device
- Rope
- Emergency blanket or bivouac bag
- Whistle
- First aid kit
- Flashlight and headlamp
- Pocket knife, multi-tool
- Small folding saw
- Matches, lighter, fire starter,
- Bear-proof container or material for setting up a bear bag
- Food in sufficient quantity
- Water filter
- Water bottle for drinking water
- Bowls, utensils, cups, plates
- Stoves and fuel
- Compass
- Topographic map
- GPS, cell phones with offline maps
- Sleeping bag
- Tent
- Ground mattress
- Hat, cap
- Tuque, gloves
- Raincoat
- Suitable footwear
- Breathable and warm clothing
- Shovel if needed
- Sun protection, sunglasses
- Biodegradable soap
- Bags to bring back the waste

# WHEN YOU GET HERE

## ARRIVAL



› **STARTING AT 1 P.M.**

### Reception:

Directly at the Rupert Welcome Center  
Open 7h45 a.m. to 4 p.m., Monday to Saturday,  
from June to September

### Services:

Motor rental available at the Penicouane Bay  
camping everyday from June to September

### Location:

180 km from Chibougamau – turn right at KM 132 on  
Route du Nord, follow signs for 26 km.



### Access:

26-km access road,  
maximum speed around 40-50km/h



**Water is not drinkable** at this location. It is recommended that visitors **boil the water** available onsite for about 10 minutes.



**Dogs are prohibited** in all buildings on the wildlife refuge, except for duly identified guide and assistance dogs. **Other domestic animals are prohibited** at all times.



**Smoking is strictly prohibited** in accommodation areas and rental units as well as in all public buildings.



Due to the geographical remoteness of the AAMW wildlife sanctuaries, **the territory is not covered by the cellular network**. These communication constraints and the distance from hospitals and emergency services can cause significant delays when an emergency response is required.



You are encouraged to bring your **own device** for emergency communications.



**It is strictly forbidden to ride an ATV** (all-terrain vehicle) in the wildlife sanctuaries.



The use of a **jet ski is strictly prohibited** on all bodies of water.

## REMINDER FOR A SAFE AND RESPONSIBLE STAY

“Outdoor activities may entail certain risks. **You must therefore always make sure that you have the skills and abilities required by the chosen activity.** It is very important to be aware of the risks inherent in that activity, to know and respect your abilities and to have the appropriate equipment with you in all cases.”

Buildings at this location belong to the Neeposh family and are not available for visitors.  
Thank you for respecting the premises. Thank you also for not using generators between 10 p.m. and 7 a.m.

# FISHING



## CATCH-AND-RELEASE

**Catch-and-release fishing is mandatory for Robineau Lake and nearby water bodies in the sector.**

Consumption of fish is permitted onsite only.

All fish, released in the water or consumed, must be declared on the catch record of each group of anglers.



## Watercraft provided with the *Mûs* prospector camp

**package:** 2 verchères and 2 canoes (motors not included). There is also 2 SUP on site. Motors not included. Fiberglass verchère, maximum 15-hp short-shaft motor. You must bring your own motor or rent one at Pénicouane Bay (to be planned when making your reservation).

**Safety equipment:** Adult-size personal flotation devices (PFDs) are available to you along with manual propelling devices. For young children, bring your own PFDs appropriate to their size.

**The boating safety kit is compulsory under federal regulations. Included with all boats.**



## On the water:

- Don't forget that **navigating on large unmarked stretches of water requires constant attention**, as there are many rocky outcrops and weather conditions can change rapidly and become dangerous.

## ATTENTION, ANGLERS!

**Access rights are issued on the day.** They are therefore valid as of the time of issue on the day you arrive **until 11:59 p.m.**  
A daily access right must be obtained for each day of fishing.

## AVOID FINES

- › Release your **catch in the water**
- › Have a copy of the **access right** to the body of water on you and visible in your vehicle
- › Have your **fishing license** on you at all times
- › Wear a **personal flotation device** (PFD)
- › Have a **boating safety kit** in your craft
- › Have your **Pleasure Craft Operator Card** with you in your boat

**As stipulated in the regulation on wildlife sanctuaries, all those who engage in fishing activity must, when leaving the wildlife sanctuary, make a report of that activity at the place determined for the purpose, indicating daily catches.** Failure to comply with that regulation is an offense and is subject to a minimum fine of \$250.



# BEFORE LEAVING

## DEPARTURE:



› **BEFORE 12 (NOON)**

**Cleanliness:** A \$100 housekeeping charge may be billed to clients who do not leave the premises in clean condition.

Please return your waste to the appropriate containers.



**Dispose of fish carcasses appropriately to avoid attracting wildlife on the site.**

## TERRITORY

Since it has more than 5,000 lakes, it is very difficult to ensure quality access and up-to-date information for all water bodies.

Several users circulate and occupy the territory, which can accelerate the deterioration of the roads. Thus, it is not possible to guarantee the condition of the paths and the water launches. Access is at the customer's own risk.

Access fees are non-refundable.
